Carla provides leadership in directing, planning, and evaluating multiple programs within a complex, integrated service delivery system and oversees the Economic Services Programs, including the Child Support Program, Temporary Assistance for Needy Families (Work First), Energy programs, Office of Refugee, Continuous Quality Improvement and the Customer Service Call Center. Carla also oversees the Division of Aging and Adult Services, whose mission is to promote the independence and enhance the dignity of older adults, persons with disabilities, and their families through a community-based system of opportunities, services, benefits and protections.

Carla serves on the board of the National Child Support Enforcement Association (NCSEA), is a member of the Policy Forum and CSQ committees and is co-chair of NCSEA's 2022 Leadership Symposium. A past president of the Eastern Regional Interstate Child Support Association (ERICSA), Carla is a member of ERICSA's Honorary Board. She is a board member of the North Carolina Child Support Council and is on the board for the North Carolina Council for Developmental Disabilities.
